On 3/9/2019 at 0923 hours Arrestee-Edward Kneipher (Kneipher) was involved in an auto-bicycle accident on 3rd Ave and Main St in the City of Longmont. Kneipher was on the bicycle. Kneipher was cleared through CCIC/NCIC and found to have a valid misdemeanor FTA warrant out of Longmont PD for larceny with \$100 bond, DKT #C0872018m000871.

A paramedic was treating Kneipher and removed his shoes and socks. A bag with suspected meth-amphetamine fell out of Kneipher's sock. There was also syringes located in Kneipher's belongings. One syringe was "loaded" with suspected liquid meth. Both tested presumptive positive for meth-amphetamine. The contents of the baggie weighed 3.02 grams and the liquid weighed .04 grams.

Kneipher was medically cleared at Long's Peak Hospital, then booked at Longmont Police Department and then transported to Boulder County Jail.
